#### Message from the MusiQuE Board

It is with great pleasure that the Board of MusiQuE would like to give you an update on the work of MusiQuE in 2018. We are proud to report that MusiQuE is doing well.

Over the past few years, MusiQuE has seen a significant growth in terms of the number of procedures, the development of new services and approaches to external quality assurance, and its international reach. The positive feedback we have received, both from institutions reviewed and from our peer reviewers, confirms the health of the higher music education sector, and the importance of our work in providing a quality benchmark for the sector in Europe and, indeed, throughout the world. Its efforts have been acknowledged in a report published by the European Commission in 2018 about the latest developments in quality assurance in the European Higher Education Area, in which MusiQuE was identified as an example of good practice<sup>1</sup>.

The organisation has also significantly professionalised its overall operation by expanding its staff and taking a rigorous approach to its own self-evaluation through surveys and the feedback from the external evaluator. The Board greatly benefited from the input of the first student member to the Board, who started in February 2018.

The MusiQuE register for peer-reviewers is expanding. The peer-reviewers come from AEC member institutions, but increasingly also from EMU and PEARLE\*. As every year, a workshop was held in November 2018 to train new and update experienced reviewers, including a growing number of students.

MusiQuE is registered with EQAR, the European Quality Assurance Register for Higher Education. This is significant and means that, at the European level, we have the same status as national quality assurance agencies. We have also secured agreements with various European agencies, and therefore able to carry out independent or joint accreditation procedures in various European countries; and our services are increasingly sought internationally.

Despite these impressive achievements over a short period of time, MusiQuE is also facing challenges. Most of these are connected to the situation that cross-border quality assurance is still not a fully accepted phenomenon in all countries belonging to the European Higher Education Area, despite the fact that this ambition has been clearly expressed in various ministerial communiques as part of the Bologna Declaration process. Even with its registration on the European Register for Quality Assurance in Higher Education (EQAR), MusiQuE is still not able to function independently in all EHEA countries and in some countries where it can, it has to charge fees while national agencies do not have to do so, giving an uneven level playing field for MusiQuE. Furthermore, the functioning of MusiQuE as an international quality

assurance agency is challenging in that it requires significant investment in terms of time and resources to meet the many different national requirements and rules with regards to external quality assurance.

As can be read in this report, this challenging context has not stopped MusiQuE from taking significant steps forward. We should therefore express our sincere gratitude to all those that are working hard to make MusiQuE a success. Firstly, to our partner organisations AEC, Pearle and EMU for their trust and continuous support to the development of MusiQuE. And finally, to all MusiQuE reviewers: they are all helping us to realize our mission of working internationally to uphold and advance the quality of music education.

#### About MusiQuE

MusiQuE is an external evaluation agency dedicated to the continuous improvement of the quality of higher music education across Europe and beyond. MusiQuE's work is subject-specific and is characterized by flexibility, diversity, transparency and accountability. Its operations are underpinned by independent, skilled and authoritative international peers.

MusiQuE offers a range of services tailored to the needs of higher music education institutions: quality enhancement reviews and accreditation procedures for institutions, programmes and joint programmes, joint procedures with national quality assurance and accreditation agencies, evaluations of research activities, consultative visits, coordination of benchmarking projects, etc.

MusiQuE was established in October 2014 by the following three organisations, which have become MusiQuE's direct partner organisations: the Association Européenne des Conservatoires, Académies de Musique et Musikhochschulen (AEC), the European Music Schools Union (EMU) and Pearle\* Live Performance Europe, the European Federation of Music and Live Performance Organizations. In this way MusiQuE functions as a unique partnership of the higher music education sector and the music profession and thus its work is assured and relevant in terms of the professional demands of today's world of music.

MusiQuE operates according to the Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG) and is registered on the European Quality Assurance Register (EQAR). As such, MusiQuE is a leading player in higher education quality assurance in general, working with the institutions in which its procedures are applied to construct a broadly-supported quality culture tailored to the specific contexts and characteristics of higher music education.

A permanent seat for a Student member of the Board was established in 2017 and the first Student Board member joined the Board in February.

Helena Maffli left the Board in May 2018. The MusiQuE Board and staff would like to express their gratitude to Helena for her commitment and considerable input in MusiQuE's activities. Based on the



proposal made by the EMU Council, the vacant seat was filled by Timo Klemettinen who joined the Board in December 2018.

At the end of 2018, the Board decided to renew the term of MusiQuE's Secretary and Treasurer Gordon Munro until November 2021.

#### Peer-Reviewers Register

Peer-reviewers form the panels that carry out the reviews commissioned by the Board of MusiQuE: in line with its subject-specific focus, MusiQuE works with a pool of international experts in relevant musical fields, who are familiar with and well informed about the specificities of higher music education.

Since October 2017, the criteria for the recruitment of peer-reviewers have been adjusted to allow for a greater diversity of profiles. The first peer reviewers originating from EMU and Pearle\* were added to the MusiQuE register in spring 2018 and MusiQuE is working on including more reviewers from the music profession, including by inviting experts within the Pearle\* and EMU communities to the annual MusiQuE Training for Peer-reviewers. Attending this training is one of the criteria to become listed on the Register. In addition, existing members of the Register are expected to update their familiarity with MusiQuE's standards and procedures by taking part periodically in the training.

In 2018, an analysis of the register was made, which demonstrated it included 80 experts from 29 countries speaking all together 14 languages. 65% of the reviewers were male and 35% female. The majority of them held a senior management position (33); the other reviewers were heads of departments (15), professors/teachers/lecturers (14), individuals holding a senior administrative position (7), retired (6) or in other roles (5). The fields of expertise mostly represented in the pool were: classical music, composition, music pedagogy and artistic research.

#### **Peer-Reviewers Training Sessions**

In November 2018, the MusiQuE training session for Peer-Reviewers took place at the University of Music and Performing Arts Graz, Austria. 41 experts from all around Europe, including 7 students, participated in the training. This year's programme featured a newcomer's session as well as 'peer-to-peer' session for more experienced reviewers. The training session elicited very positive feedback from both participants and trainers, which will inform the training session in 2019. #### **Review Procedures**

During 2018, 11 procedures were carried out in 7 countries. #### **Finances**

Although MusiQuE's general level of activity increased quite substantially in 2018, with 11 review procedures (compared to 6 in 2017), the profit and loss statement shows a rather similar picture in 2017 and 2018:

- The direct income from reviews is slightly smaller in 2018, for two reasons. First, it does not include the income from two procedures in Belgium, for which invoicing was postponed until MusiQuE would obtain a VAT number in Belgium; in addition, in the context of the diversification of MusiQuE's services, some procedures were of smaller scale and therefore did generate less income than regular review procedures.
- On the expenditure side, review costs amounted to less than 50,000 euros, operational costs were maintained at a reasonable level and staff costs increased.

The profit and loss statement shows a positive result of 7,302€ (very similar to the 2017 result). This is consistent with the decision of the MusiQuE Board to create a reserve over the coming years with the aim to finance the next external review for EQAR in 2020.

#### Note on the staff costs

Based on the agreement between the three founding partners of MusiQuE, AEC, EMU and Pearle\* to offer their financial support to MusiQuE in order to guarantee its financial viability in its first years of operation (without compromising its independence), staff costs of the MusiQuE Office in Brussels are covered by AEC, and progressively reimbursed by MusiQuE, until financial independence is reached. In 2018, as in 2017, MusiQuE reimbursed 50% of the total staff costs covered by AEC. In addition, for overhead costs covering the daily operation of the MusiQuE Office, an annual contribution to AEC calculated on the basis of 7% of MusiQuE direct costs is paid to AEC.

#### **Internal Quality Assurance**

MusiQuE has developed a robust internal quality assurance system, which provides the MusiQuE Board with relevant feedback on the organizations fitness for purpose.

#### **External evaluator**

Since 2016, Stefan Delplace, Honorary Secretary General of the European Association of Institutions in Higher Education (EURASHE), and an educationalist specialized in Business-Education cooperation, Quality Assurance, Recognition and Accreditation issues, has been serving as the External Evaluator of MusiQuE. His role is to review material documenting MusiQuE's activity, as well as to monitor the compatibility of MusiQuE's systems with the ESG. In 2018, the Board of MusiQuE extended Mr. Delplace's tenure for a further two-year period. In his 2018 report, Stefan Delplace highlighted the important progress achieved by MusiQuE, from establishing student representation on its Board to widening stakeholder's involvement. The Board expresses its gratitude to Mr. Delplace for his work in ensuring the quality of MusiQuE's systems and processes. The reports of the External Evaluator are published on the MusiQuE website.

#### Results of feedback questionnaires and improvements to MusiQuE review procedures

Feedback from institutions reviewed, and from members of Review Teams is considered annually by the Board of MusiQuE which then decides on any action to improve systems and processes or to fine-tune the Standards.

The feedback received from institutions has been very positive in 2018: institutions "recognise [them]selves in the recommendations that have been formulated", appreciated that "MusiQuE provides more opportunities [than the national procedures] for the programme to reflect" and "plan to integrate the recommendations into [their] quality enhancement follow up-plan".

Some suggestions for improvements were also made, such as the integration in the reviewers' reports of the definition of compliance level statements or the earlier communication to the institution of the classes which members of the Review Team have chosen to attend.

MusiQuE also collects suggestions for improvements to its various sets of standards for the Standards revision process undertaken every four years.



#### Communication and external relations

Bringing MusiQuE's activities, and the higher music education sector in general, to the attention of a wide audience is MusiQuE's continuous mission. In that regard, its services, activities and approach to quality and quality assurance have been presented on several occasions in 2018:
